Frequently Asked Questions

What is Printed Battery?

Printed Battery is a rechargeable lithium-ion power source.

Who manufactures Printed Battery?

The "1stPAQ©" Battery is the patented product, with which 1stChoice-EPA has the exclusive license to sell Printed Light in Texas and through Texas Offices of 1stChpoice-EPA, in the United States (excluding the Virgin Islands). Printed Battery is developed and manufactured in the United States.

Can it be used outdoors?

Printed Battery can be used outdoors as long as it is enclosed.

Can I bend it?

Printed Battery is not flexible.

What are the standard sizes?

There is one standard 192 Wh cell. These cells are used to make 770 Wh, 1.5 kWh, 2.5 kWh, 5kWh, 7.5 kWh, and 10 kWh batteries.

Can I customize Printed Battery?

Yes, but only using the standard cell.

What is the price?

What is the minimum order quantity per size?
There is no minimum order quantity.
How long does it take before an order is shipped?
An estimated time of arrival will be provided at the time the purchase order is submitted. Most orders take 2-3 weeks.
